Buckinghamshire County Council has already given its opinion to **OBJECT** to the planning application, and ask for the permission to be refused by the Secretary of State.

The planning application is on appeal and will be decided by the Planning Inspectorate on behalf of the Secretary of State.

### REMEMBER.....

- If it opens, you will be CHARGED FOR ALL WASTE the Council sites do not charge you for household waste.
- This will not be a Council run waste site with all the statutory protections it will be PRIVATELY OPERATED and likely to be run by inexperienced operators.
- FOI disclosures prove that there have already been discussions about ADDING TRADE WASTE (eg building materials), INCREASING the waste taken by a factor of 5 TO 25,000 TONNES and with an INCREASE IN HGV TRAFFIC through the village.
- 4. QUEUES on Wigans Lane will return with the 95,000 VEHICLES and all the NOISE and POLLUTION – this site DOES NOT AND CANNOT MEET modern design and safety standards.
- 5. LITTERING will return to our roads and laybys we all hate flytipping but the tipping we have would not be accepted by this site fly-tippers do it because they do not want to pay charges;

  pollution and loss of wildlife.
- Buckinghamshire County Council has already decided to close this site following a full consultation and also recommends that this permission is not granted.
- This must be considered as a new planning application.
- There has been inadequate consultation and a lack of proper surveys and assessments to determine the impact on all aspects including the queues that form on the road and the potential traffic problems caused by continuing local housing development.
- The site is not fit for purpose it is old and poorly designed with little space for traffic and pedestrian movement with hazards inside and outside the site.
- It is poorly located beneath the summit of the Ridge.
- Other alternatives outside the AONB/greenbelt have not been considered.
